Important considerations

Expected number of volunteers: about 25 needed, mainly for the hospitality suite.

We should try to get new possibilities for hotels following the guidelines below by the end of July, if possible.

We should determine interest of the fellowship for the service position responsibilities on page 3.

Timeframe: first week of August 2022. FWS would like to make announcement on location on last day of ABM 2021, if possible.

This ABM will be fully in person (not virtual or hybrid)

Immediate needs (to be completed by the end of July 2021)

■ Hotels

- Location
 - Find hotels that are within a reasonable distance from an airport (My comment: it seems that no one would want to go to a hotel near JFK, but we could explore Manhattan, Brooklyn, nearby areas in NJ like Jersey City)
 - Area must not contain strip clubs, etc. that are not conducive to recovery
 - Near public transportation
- o Rooms
 - Hotels must have 50 sleeping rooms available
 - Room nights: 50 rooms on Monday, Tuesday, Weds, Thursday, and Friday (5 nights @ 50 rooms)
 - 10 additional room for board and staff (on Friday-Sunday night)
 - Total number of room nights: Approximately 280
 - Keep cost down to around \$100-\$135 at most (if possible)
- Ballroom and meeting rooms
 - Must contain ballroom that seats at least 60 (with a hollow square configuration where participants can walk in the middle of the configuration)
 - 4 or 5 breakout rooms (at least) that comfortably seat 20-30 in a conference room setup configuration

- Hospitality suite (could be a Presidential Suite, guest suite, or a large breakout room). Ideally it will contain:
 - A refrigerator (large) or two small ones
 - Access to running water for washing utensils, rags, etc.
 - A Microwave
 - Soft seating (sofa, comfy chair) for approximately 30 people; many hotels will charge about \$100 to remove beds and replace them with sofas, cushy chairs
- Dedicated board room (convenient for the ballroom, breakout rooms)-- board will come in a few days beforehand --> board room used before up to the last minute. Board room should contain:
 - Refrigerator
 - Microwave
- Meals (biggest variable!)
 - 50 people/day served
 - In-house catering, on-site restaurant
 - Tuesday lunch and dinner; Weds breakfast, lunch, dinner; Thursday breakfast, lunch, dinner; Friday - breakfast, lunch
 - Include options for dietary restrictions
- Audio/visual needs (could be rented from outside the hotel, if needed)
 - At least 6ft x 6ft screen (preferably 8ft)
 - Microphones
 - Outlets (needed for laptops; rig plug-in system?)

Transportation

- Parking: (seems like a non-starter in this area, but we could offer prices of nearby garages)
- Public transportation options (the simpler, the better; midtown has LIRR line from Jamaica Queens and NJ Transit from Newark; probably will not recommend LGA)

Service positions needed for hosting ABM

- Hospitality suite chair (coffee, juices, salty/sweet snacks, etc. with different meal options
 - Organizes team of at least 12 reliable volunteers
 - Hospitality suite open all day except during mandatory sessions
 - Volunteers have local knowledge and are trained to answer key questions
 - o Offer local interest suggestions
 - Opportunity to meet members from across the world.
 - Ideally 4 hour shifts
 - Minimum of \$500 budget
 - Include 7th tradition jar
- Chair, local planning committee,
- Meeting chair
 - Plans 2 meetings/day -- one in the morning and one in the evening at 6/7pm)
 - Speaker meeting on Thursday night (local planning committee will pick out that chair).
 Just a speaker meeting ONLY.

- Outing/activity chair
 - o Plans fun activity outside of hotel (ex: scavenger hunt, walking tour)
 - o Raffle on Wednesday night --> need an auctioneer, people helping out doing bids, etc.

Possible IRC prior to ABM

Do we want to run an international recovery convention prior to the ABM? This would be on us. It would be Friday-Sunday before the ABM (late July-early August)
