The ending balance is \$9721.77.

It was discussed that 10% of the total 2020 contributions to Greater NY Intergroup will be donated to FWS. Cara will present that figure in the next meeting. Sam confirmed that this is the customary figure. Cara also noted that she would include both a YTE (year-to-end) and YTD (year-to-date) figure in the spreadsheet for calculation purposes. It was discussed that the NY IG may wish to split our contributions into two-month intervals so as to take advantage of the added contribution from the Lifesaver program. This discussion will take place again next month.

Diana Mohyi, the lawyer, discussed the delay regarding the 501C-3 application with the IRS. It may take six months or more for the letter to be sent. It will delay the rest of the incorporation process. Diana also noted the need for officers, especially the treasurer, to have a background check to ensure that they have never had a felony conviction. This is particularly important for safeguards surrounding money and finances of the organization.
