#### Reports

#### Secretary (Anne)

Minutes read, as they appeared in the agenda document distributed to the mailing list prior to the meeting. No questions raised. Minutes approved unanimously

#### Treasurer (Cara)

The full report was distributed with the agenda. Summary follows:

- Liquid balance \$7k
- Bank balance \$10k
- YTD expenses \$12.8 k
- YTD income \$7.9k

This year expenses substantially exceeded income — spending down a donations bump that we got during the pandemic shut down. Major expenses were Share-a-Day and ABM, in addition to insurance. Last year the income was slightly less than this year, but expenses were less than half of income

We are still donating \$200/mo to FWS. Should we continue?

# Communications (Dan)

We received 16 e-mails. 10 were inquiries about in person meetings.

We don't have any Hudson Valley Meetings on our radar. We think there is still one in Kingston. Information would be desirable.

We got several sponsorship inquiries, and a sponsor was added to our list.

There were also inquiries about submitting material for the basic text re-write.

We got an order for \$100 of our literature, of which we have about \$3k. We may need a literature chair.

Dan has not yet checked what is going on with Vonage. He thinks they discontinued their text to e-mail service. We aren't getting messages from them.
