Reports were given on

Treasury: The ending balance is \$14,867.

Cara (the treasurer) checked in with David (the previous treasurer) on FWS contributions. Everyone from ABM has been reimbursed.

Mark S. read David's reply to Cara's question regarding FWS contributions: "The amount of the SLAA intergroup contribution to FWS should appear in the spreadsheet in one of the prior years. 15% of income comes to mind. For St. Francis, I thought it was a dollar amount per year not a percentage, but I just don't remember. St Francis always characterized it as a "donation" rather than "rent" and I suspect fellows could have an issue giving St. Francis a donation after more than a year of no in person meetings. Maybe bring up at IG?"

Cara will review whether St. Francis is requiring insurance now that some in-person meetings have resumed there. Questions include: When should the insurance be resumed? How much will it be?

Literature: The balance in the literature account is \$555.45. There was one sale of literature during the month of September.

Ancillary reports:

ABM discussion of hotels and application. FWS had some questions regarding our application, which was considered to be incomplete. Additional information was sent to Gabriel G, the board liaison regarding the application. Sam F. stated he would contact Gabriel G. to determine if there are any hold ups with the application.

The Chair will ask the Vice Chair about his participation in the hybrid meeting equipment subcommittee.

The Steps Committee provided answers on the service forum in regard to traditions issues surrounding New York's new in-person combined SLAA/AA meeting in Bushwick (Brooklyn).
